#### **Historical Information:**

Both Oyster Bay and East Norwich's schools have a long history. The Oyster Bay school system began with the support of James Townsend of Oyster Bay who was on the Board of Regents of Columbia University from 1784-1787. In April, 1802, he helped establish the Academy from which the public schools of Oyster Bay developed in 1865. The East Norwich school system had its official beginning at the annual meeting of elders on February 2, 1838. The Oyster Bay-East Norwich Central School District was created on July 1, 1960 by the action of the voters in the former Oyster Bay and East Norwich School Districts. ### **Scope and Content**

This collection documents the activities of the Oyster Bay East Norwich Public Schools from the years 1839 to 1972 with the bulk of records in the years between 1915 and 1927. Press releases, notices, newsletters, reports, budget information, invoices, cancelled checks, correspondence, deeds, insurance policies, legal papers, health reports, minutes, newspapers, and specifically records of the board of education from 1849 to 1950. Included is a series designated to the records documenting the proposal of a new school building (1964-1966). It contains brochures, several reports on the problem of overcrowding in the public school system. There are many gaps in the documentation.
